Malungu

Ukuhambelana Kwe-UKSU ne-POPIA Umyalezo Wamalungu Obalulekile.

I-UKSU isithathe izinyathelo ezifanele ukuze ihambelane nezidingo zomthetho i-Protection of Personal Information Act [POPIA or POPI Act].

Lo myalezo uqukethe ulwazi olubalulekile kumalungu, sicela niqaphele lokhu okulandelayo:

- 3) Izicelo mayelana ne-POPIA kufanele zithunyele ku-Information Officer parkiesr@ukzn.ac.za nekhophi iye ku-imeyili wenyunyana ethi uksu@ukzn.ac.za.
- 4) Lo myalezo wazisa amalungu akhona ngokuthi imininingwane ayinikeze i-UKSU, ngesikhathi efaka izicelo zobulungu, igciniwe futhi iyasetshenziswa ngokokwenqubomgomo i-UKSU POPIA Policy.
- 5) Umthetho i-POPI Actawukuvimbi ukuqoqwa kwemininingwane yomuntu kodwa udinga ukuba labo okuqoqwe imininingwane yabo, baziswe ngokuthi le mininingwane izosetshenziswa kanjani futhi izogcinwa kanjani ngendlela ephephile. [bhaka inqubomgomo].
- 6) Amalungu ayaziswa lapha ukuba:
 - Amafomu awo ezicelo zobulungu adluliselwa kwa-HR Rewards, ukuze kulungiswe indlela yokukhokhela ubulungu nyangazonke – i-BCEA, esigabeni 34(1)(a) idinga ukuba kube nemvume ebhaliwe yokubanjwa kwemali yobulungu, ngakho iNyuvesi iphoqelekile ukuba iyigcine le mvume;
 - Inqubomgomo yase-UKZN ye-POPIA iyasebenza kulezo zicelo zobulungu ikakhulukazi lobu bulungu benyunyana bubizwa nge-“special personal information”;
 - Ikhophi yefomu lesicelo sobulungu be-UKSU ligcinwa ngobuchwepheshe yi-UKSU;
 - Amalungu aba yingxenye yohlu lwamalungu ukuze athole imiyalezo ekhishwa yiSigungu Esiphezulu – amalungu angacela ukuba amagama awo asuswe kulolu hlo ngokuthi abhalele i-Information Officer parkiesr@ukzn.ac.za ne uksu@ukzn.ac.za.
 - Ngezinye izikhathi, izithombe zemcimbi ye-UKSU ehlanganisa namalungu, zizofakwa esizindalwazini kanye/ noma ekhasini lika-Facebook page – amalungu angacela ukuba izithombe ezinawo zingafakwa ngokuthi abhalele i-Information Officer parkiesr@ukzn.ac.za ne uksu@ukzn.ac.za.
 - Ilungu lingayalela i-UKSU ukuba ingayigcini imininingwane yalo njengokuhlinzekwa kwazo kwifomu lesicelo sobulungu ngokubhalela i-Information Officer parkiesr@ukzn.ac.za ne uksu@ukzn.ac.za.
- 7) Yize noma kunephuzu 6, uma ilungu ngomuso linesifiso sokuyalela i-UKSU ukuba isuse igama lalo ohlwini lwamalungu, ingazifaki izithombe zalo kanye/noma ingayigcini imininingwane yalo, lingakwenza lokhu noma nini ngokulandela iphuzu 3.
- 8) Kufanele kuqapheleke ukuthi uma ilungu liyalela i-UKSU ukuba isuse imininingwane yalo, kuzofanele lisule ku-UKSU ngoba le mininingwane iyadingeka njengamarekhodi amalungu e-UKSU futhi nokulekelela ekuhlinzekweni kwezidingo kumalungu e-UKSU.
- 9) Ifomu lobulungu be-UKSU selichitshiyelwe ukuze libe nolwazi olubhekiswe kumalungu amasha mayelana ne-POPIA, okuhlanganisa nemvume yokuhlela, ukusebenzisa, nokugcinwa kwale mininingwane. Ikhophi inanyathiselwe.

- 10) Amalungu akhona awadingekile ukuba alethe ifomu elisha lobulungu ngoba le mininingwane asenikiwe yona.
- 11) Yonke imiyalezo yangomuso izohlanganisa nesikhumbuzo sokuthi amalungu angakwazi ukuba AHOXISE UBULUNGU neminingwane yokuthi kwenziwa kanjani.
- 12) Ikhasi le-UKSU le-Facebook lizoguqulwa libe yikhasi leqembu elivalelekile kungakashayi umhla lu-1 kuNtulikazi (July) 2021.
